

“KATY DAYS GOT TALENT”

Rules and Regulations

I. Entry Procedures

1. You must complete an Official “Katy Days Got Talent” Participant & Release Form.
2. Performers under 18 years old must have the Participant & Release Form signed by a parent/guardian.
3. Completion of the Official “Katy Days Got Talent” Participant & Release Form does not guarantee a place in the competition.
4. Entries may be limited to the first 25 entries.

II. Performance

1. Prepare two (2) 90 to 200 second routines.
2. Singers may use a CD backup (without vocals) or sing a cappella.
3. Songwriters/musicians can sing to a track of an original work or cover and/or play your own instrument.
4. Bands are excluded and will not be given a place in the competition..
5. No fire, sharp objects, weapons or explosives (pyrotechnics) allowed.
6. Each act must perform live, vocally and/or instrumentally. No special lighting, props or special effects may be used.
7. All performances must be done in good taste: NO profanity or vulgar lyrics in any vocal performance or dance music.
8. NO Nudity allowed! Keep attire at a respectable and tasteful level.
9. Sound Technician and microphone(s) will be provided. **YOU** must provide your own CD music, taped music, instruments, props, keyboard, etc., if needed.

III. Judging

1. The decision of which Friday night acts will move forward to Saturday afternoon will be judged by individuals assigned by the “Katy Days Got Talent” Committee for the expressed purpose of judging the “Katy Days Got Talent” Friday night auditions.
2. The Saturday afternoon finals, which include a different performance than that given in the Friday night auditions, will be judged by individuals assigned by the “Katy Days Got Talent” Committee for the expressed purpose of judging the “Katy Days Got Talent” finals.
3. The number of acts moving on to the Saturday afternoon finals will be determined by the “Katy Days Got Talent” Committee and all decision are final.

IV. Prizes

1. First Place \$500.00
2. Second Place \$200.00
3. Third Place \$100.00

V. Disputes

1. The “Katy Days Got Talent” Committee is authorized to resolve all disputes at “Katy Days Got Talent” competition.
2. The “Katy Days Got Talent” Committee is the sole authority in resolving all disputes at the competitions and to disqualify any contestant for failure to comply with the rules and regulations, including errors and omissions.
3. The “Katy Days Got Talent” Committee decisions are final.

VI. Assumption of Risk

1. By submitting the Participant & Release Form, the act (and each individual member thereof) assumes all risks of property damage or bodily injury (including death) that might occur during the “Katy Days Got Talent” event.
2. The act (and each individual member thereof) agrees not to bring against “Katy Days Got Talent” any claim for property damage or bodily injury (including death) that might occur during the “Katy Days Got Talent” event.
